

Investment objective

Aim: The fund is designed to achieve returns above the rate of inflation over a five year time period for an investor who is lifestyling towards an annuity or drawdown end point.

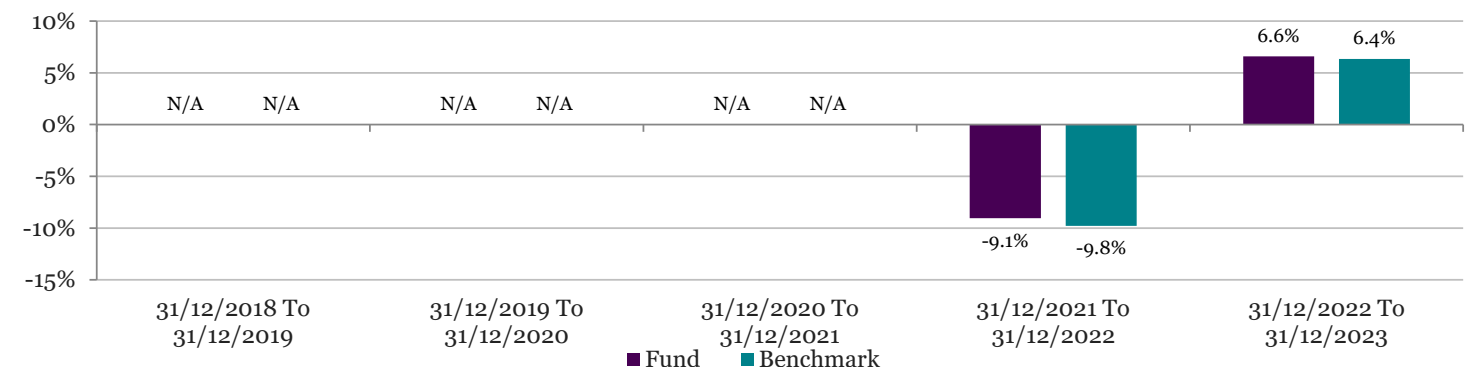
