

Protection Deed of Appointment (Absolute)

Introduction

For use with the following trust forms provided by Royal London (or the divisions known as Bright Grey and Scottish Provident):

Royal London Split Trust Royal London Split Trust (Jointly owned plans – survivor to benefit) Royal London Business Trust Scottish Provident Split Trust Scottish Provident (Joint Life, First Event) Scottish Provident Probate Trust Scottish Provident Business Trust Bright Grey Split Trust Bright Grey Split Trust +30 Bright Grey Business Trust.

You can use this deed to appoint that the plan proceeds in the trust are to be held for specific beneficiaries within the wider group of discretionary beneficiaries, as determined by the trustees after a claim has been paid. The plan proceeds can then be distributed to the chosen discretionary beneficiaries.

The Appointers, in exercise of the power of appointment conferred by the Settlement, hereby irrevocably appoint and declare that the Appointed Part shall from the date of this Deed be held upon trust absolutely for the Appointed Beneficiaries in the amounts specified in the Schedule of Appointment and revocably appoint and declare that the Retained Part shall be held subject to the trusts declared in the Settlement.
