IMPORTANT CHANGES TO YOUR ROYAL LONDON INVESTMENT

Your pension plan is currently invested in the above fund. As part of our ongoing review process, we have identified that the underlying investment has experienced a sustained period of underperformance and no longer have confidence in the manager's investment process and ability to deliver strong future performance.

We have decided to remove this fund from our fund range and switch your investment into RLP/Schroder MM Diversity Balanced. This change will take place week commencing 9 November 2015.

As a result of this change the fund management charge applied to your plan will change from 1.70% to 1.35%. The Total Expense Ratio (TER) of the RLP/Schroder MM Diversity Balanced is 2.09%.

You should consider whether this is an appropriate investment for you.
