Royal London Fund Closures

We regularly review the Royal London pension fund range to ensure the available funds remain appropriate to our customers. A recent review has identified some externally managed funds that aren't providing value for money for our customers. We have taken the decision to close these funds and move investments into replacement funds.

These fund closures also impact some lifestyle strategies that we offer. We have taken the decision to close these lifestyle strategies and redirect investments into a replacement lifestyle strategy that closely matches the existing lifestyle strategy.

If you are impacted by any of the fund or lifestyle strategy closures, you will have received a letter from Royal London providing details of the changes and when these will take place.

How have we identified suitable replacement funds?

In mapping a suitable replacement fund for investment, several principles were followed.

- Any recommended fund should be as close to the
 original fund as possible in terms of the asset classes the
 fund may invest in. For funds that take a multi-asset
 approach using several different asset classes we have
 mapped a replacement Governed Portfolio fund that is
 the closest match to the existing investment.
- Where possible the replacement fund should have the same, or as close to as possible, benchmark of the existing fund. A benchmark is a measure against which a fund performance can be compared. Where it was not possible to find an exact benchmark match, we have ensured an appropriate benchmark is detailed for the mapped solution.
- ABI (Association of British Insurers) sector where possible the replacement fund should have the same defined ABI Pension fund sector. ABI Fund sectors are a system for the classification of pension funds with similar investment strategies and sets out a list of defined fund categories, referred to as 'Sectors'. The ABI Sector Definitions set out clear eligibility criteria by reference to which pension funds that are put forward for classification are grouped into a particular ABI Fund Sector. The sectors are not designed to reflect the relative risk of funds. They are designed to group together funds that are similar, so that they can be compared on a like-for-like basis.
- Any replacement fund should not incur any additional investment charges.

Investment Advisory Committee

Lifestyle mappings

A number of lifestyle strategies are impacted by the fund closures detailed. A mapping has been carried out to identify suitable replacement lifestyle strategies. In addition to the existing fund mapping principles some additional principles were considered for any lifestyle strategy replacement:

- Retirement target any replacement lifestyle strategy retirement target should be in line with the existing targeted retirement point of the lifestyle strategy e.g. where a lifestyle strategy is targeting the purchasing of an annuity at retirement, the replacement lifestyle strategy should offer a similar solution.
- Risk Level the risk level for any mapped replacement lifestyle should be in line as much as possible with the existing lifestyle and underlying funds.
