This leaflet shows the 2020-2024 investment mix and investment returns for with profits policies in the Royal London (CIS) Sub-Fund.

The investment mix and investment return of policies varies by category of with profits policy. Each category has its own investments which generate a separate investment return for the policies within it.

This document does not cover Option 32
Traditional With Profits policies. These are invested entirely in government and other bonds.
This is because the policy guarantees are so far above the policy values, these policies effectively behave more like non profit policies.
