



## **GOVERNED RANGE MODERATELY ADVENTUROUS ACTIVE LIFESTYLE STRATEGY (DRAWDOWN) (ISA) FACTSHEET**

### **What is a Lifestyle Strategy?**

As you approach your target date, you'll probably want to reduce your investment risk. This Lifestyle Strategy is designed to help you do that. Your investments are gradually switched from higher to lower risk portfolios as you get closer to target.

The Lifestyle Strategy is not compulsory. You can start or stop it at any time, but it must apply to all contributions to your plan.

### **What governance process is in place?**

Your Lifestyle Strategy comes with ongoing governance. This simply means that our investment experts check it regularly. It allows us to maintain the best mix of assets in line with the risk category - and to make sure it is performing in line with its overall objectives - aiming to give you the best returns. The value of your investment can go down as well as up and you may not get back the value of the original investment.

If our experts decide that the mix of assets needs to be adjusted, it happens automatically on your behalf, you don't need to do anything. What's more, this service comes at no extra cost.

### **What is the investment objective?**

This strategy aims to deliver above inflation growth in the value of the fund at reach your target date. It has been designed to support regular income withdrawals when you reach your target date, whilst taking a level of risk consistent with a moderately adventurous risk attitude.

### **Where is the strategy invested?**

The strategy is invested in the Governed Portfolios shown. The mix of assets in each Governed Portfolio may change at any time in the future if our investment experts decide that a different blend of assets is more appropriate. It's an automatic process and there's no charge for it.

Please note that RLS Global Blend Core Plus (RLS Global Growth) has an additional charge.

You will be automatically invested into the strategy at the point that matches your time to your target date.

As you approach your target date your money is automatically switched to ensure a gradual move between the portfolios and fund splits shown below. The switching occurs on a monthly basis.

### **Details of changes to the strategy**

The following table documents the last 3 changes that Royal London have made to the portfolios within this strategy.

<b>Effective Date of Change</b>	<b>Overview of Changes</b>
14/05/2026	<p><b>Governed Portfolio Growth (ISA)</b> Global equities have continued to advance, as strong company earnings and optimism around AI have driven indices to new all-time highs. However, uncertainty surrounding the Iran war remains and macro indicators are deteriorating. We are reducing our equity exposure, taking profits following the recent rally. We are also adding to commodities given increasing expectations of a more prolonged disruption in the Middle East. Elsewhere, we are moving further underweight bonds. Yields continue to rise globally, especially at the longer end in the UK in the aftermath of the recent local elections.</p>
23/04/2026	<p><b>Governed Portfolio Growth (ISA)</b> Global markets staged a sharp relief rally as the announcement of a two-week US-Iran ceasefire materially reduced immediate escalation risks. Equities surged globally, with the S &amp; P 500 posting its longest winning run since October. We are adding marginally to our equity exposure, as investor attention has slowly begun to shift towards corporate earnings season, and company fundamentals remain strong. Elsewhere we are adding to commodities at the margin on strong momentum grounds, given vessel crossing through the Strait of Hormuz remains heavily constrained.</p>

<b>Effective Date of Change</b>	<b>Overview of Changes</b>
09/04/2026	<p><b>Governed Portfolio Growth (ISA)</b> Global markets continue to be dominated by the war in Iran, as volatility has remained elevated throughout the last few weeks. Attention has now turned to the US-Iran ceasefire deal with markets optimistic for a resolution but still pricing in meaningful tail risk. We are adding marginally to our equity exposure, as investor sentiment remains oversold. We are also adding back to bonds having benefited from an underweight position in recent weeks, given fears over sustained inflationary pressure. Elsewhere we are reducing our overweight position in commodities, taking profits at these elevated levels.</p>
